Stud service will be provided by Big Bend Goldens and Saddle Rock Kennels. The following requirements must be met before breeding:

1. Stud service will be provided by BBGs Perfect Gentleman @ Saddle Rock
2. The following requirements must be met before breeding:
  - The bitch must be at least two years of age.
  - A five generation pedigree will be provided (or K9 Data link).
  - Copy of the bitch's AKC registration will be provided.
  - Copies of OFA hip and elbow clearances will be provided.
  - Copy of OFA heart clearances signed by a Board-certified cardiologist will be provided.
  - Copy of up to date normal eye examination performed by a Board certified ophthalmologist within the past 12 months will be provided.
  - Disclosure of any other health defects believed to be inherited (such as, but not limited to eyelid defects, skin allergies, hypothyroidism, and temperament issues)
  - Two color photographs of bitch (body profile and head shot) will be provided.
  - Verification of full golden retriever genetic panel including DM, ICH1 & 2, PRA1 & 2, prcd-PRA, and NCL
  - Before any live breedings a brucellosis test must be done within 30 days before breeding.
3. Fee for stud service is \$2,200. A fee of \$600 (non-refundable breeding fee) is due at the time of breeding, and the remaining \$1,600 is due 14 days after whelp and prior to the stud dog owners' signing of the AKC litter registration. The stud owners are not required to sign the litter registration until the balance of the fee and reimbursement for all breeding related expenses have been paid in full.
4. Three (3) live puppies constitute a litter. If NO litter results from this breeding, or if less than three puppies are born and survive three weeks, a repeat breeding is offered. The bitch should be the same or meet the same qualifications as the first breeding. If a litter does not result after the second breeding, there will be no further obligation on the part of the stud dog owners.
5. The stud owners have the right to choose to receive a puppy from the litter in lieu of the \$2,000 Stud Fee. No additional money will be charged for said puppy.
6. The owner of the bitch warrants that this bitch has not been exposed to any other male prior to coming for breeding, and that she will be prevented from exposure to other males upon her return home.
7. Progesterone and/or LH testing is recommended for every breeding. All veterinary fees related to the bitch's breeding (i.e., smears, progesterone testing) are the responsibility of the bitch owner(s). Fresh Chilled Semen and Frozen Semen: All expenses incurred for the collection and shipment of either fresh chilled semen or frozen semen, as well as charges for insemination are the sole responsibility of the bitch owner(s).
8. No puppies from this breeding will be sold to puppy mills, pet shops, high volume breeders, commercial breeders, resale operations or for laboratory purposes. No puppies will be sold to anybody who breeds doodles, or plans to breed the puppy for any doodle or mixed breed program. If a puppy is sold under a breeding contract, the puppy must meet all breed standards and health testing set forth by the GRCA, and only be bred to AKC full

registered golden retrievers. Sale of puppies in this manner will damage the stud owner's reputation. If it is discovered that a puppy or puppies have been sold in this manner, damages of \$2500 per puppy will be owed immediately to the stud owners. Any reasonable attorney's fees incurred for the recovery of puppies out of this situation, as well as costs related to the collection of the fine, will be paid by the bitch owner.

9. Owner(s) of the bitch agree that all puppies from this breeding will be placed with a contract. The contract must specify that if the buyer is ever unable to keep the puppy, the puppy will be returned to the breeder or sold only to a home approved by the breeder. In order to help support the quality of the breed, all pet puppies must be sold under spay-neuter contracts and registered on AKC Limited Registration. Any puppy sold with full AKC registration requires the written authorization of the stud owner.
10. The stud owner shall have access to puppy families contact information if requested.
11. Owners of the bitch will notify the stud owners in writing regarding any titles earned by puppies from this breeding.
12. Owners of the bitch will notify the stud owners in writing if any puppies have significant health conditions.

This contract constitutes the whole agreement between the parties hereto. Any modifications must be signed by all parties. All parties will receive copies of this contract.
